



## **Benefits Available for Service Connected Disable Veterans**



### **0% TO 20%**

- Home loan guaranty fee exemption (MUST BE AT LEAST 10%)
- Certificate of Eligibility for home loan guaranty
- VA medical treatment card.
- Vocational Rehabilitation and Counseling under Title USC Chapter 31 (10%)
- Service Disable Veterans Insurance (Max of \$10G coverage) must file within 2 years of decision
- 10 point Civil Service preference
- Clothing allowance for veterans who use or wear prosthetic or orthopedic appliance
- Temporary total evaluation (100%) based on hospitalization for a service connected disability in excess of 21 days; or surgical treatment for service connected disability necessitating at least 1 month of convalescence or immobilization by cast, without surgery of more major joints.

### **30% In addition to the above:**

- Additional allowance for dependent (spouse, child(ren), full time students between the ages of 18 and 23 and parent(s)
- Additional allowance for a spouse who is a patient in a nursing home or helpless or blind

### **40% In addition to the above:**

- Automobile grant and/or special adaptive equipment for automobile provided there is loss or permanent loss of use of one or both feet, loss or permanent loss of one or both hands or permanent impaired vision of both eyes with central visual acuity of 20/20 or less in better eye
- Special adaptive equipment may also be applied for if there is ankylosis of one or both knees or one or both hips

### **50% In addition to the above:**

- Preventative health care services
- VA Medical Outpatient treatment for any condition except dental
- Hospital care and medical services in non-VA facilities under an authorized fee basis agreement

### **60% In addition to the above:**

- Increased compensation to 100% based on Individual Unemployability (applies to veterans who are unable to obtain or maintain substantial gainful employment due to service connected disability)

### **100% In addition to the above:**

- Dental treatment
- Waiver of National Service Life Insurance total disability income provisions
- Specialty adapted housing

### **100% (Permanent and Total) In addition to the above**

- Civilian Health and Medical program for dependents and survivors (CHAMPVA)
- Survivors and dependents education assistance under Title 38 USC Chapter 35
